

### Price Gouging Statute

## Legislative Findings and Declarations of Policy

• The continued production is threatened by a rapid decline in the prices paid to farmers for milk. The farm gate price for milk decreased by 27% from January 1990 to January 1991. The legislature finds that this substantial decrease in farm price has not been reflected in reduced costs to consumers, and that the retail fluid milk prices have been slow to respond to raw milk price decreases.

## Unconscionability

- Whether a price is unconscionably excessive is a question of law for the court. Evidence that:
  - (a) the price charged at retail represents a gross disparity between raw milk price paid to producers plus a reasonable handler's processing and distribution charge and the price at retail; or,
  - (b) increased price charged by the person was not attributable to additional charges by its suppliers, or other charges beyond the control of the person, including cost of labor

#### How we administer the law

 Calculate 200%, known as Threshold Price, for gallons, h-gal, qts. Do for two broad regions of the state: Upstate and Metro NYC. Based on milk at 3.5% butterfat.

#### THRESHOLD PRICE

For AUGUST 2003, threshold prices for milk, low fat milk, or skim milk offeretail sale in the state are:

A retailer who sells above the threshold price may be in violation of the law unless such selling price is justified as not being unconscionably excessive. Such justification includes net invoice price paid for the milk item plus actual costs incurred in handling and selling that milk item.

Compared to the previous month, the threshold prices increased \$0.21 a gallon, \$0.10 a half gallon and \$0.05 a quart in Metro NY and increased \$0.20 a gallon, \$0.10 a half gallon and \$0.005 a quart in Upstate NY. These increases reflect the underlying monthly change in the federal order Class 1price (% 3.5 butterfat) which increased \$1.20/cwt.or\$0.103/g; The threshold price is calculated by multiplying by two the total of the two components, the minimum federal order price and the premium paid for Class 1 milk.

"A gallon of 2% milk retailed for \$2.59 in our store during June. Our gallon price (cost) from Meadow Brook was \$2.0848. Our margin of profit was \$0.51 resulting in a margin of 19.5%."

"We typically like to price our merchandise at a 30% margin level. After speaking with other retailers, I found that none were aware of a threshold pricing for milk."

#### D'Agostino Supermarkets, Inc.

"We are not responding to your request because the Attorney General has no jurisdictional authority to initiate any milk price gouging investigation."

#### Temples Dairy Store

"Afer I received your letter I looked at what we were being charged for Milk! Cost: \$2.55 gal whole milk (14% 2.99 retail) We are being charged way too much! Thanks for your help we are switching milk suppliers."


#### Ameel Enterprises Inc.
